NET2GO:

- omogoča enostaven ter izjemno ugoden brezžičen dostop do Telemachovega mobilnega interneta,
- je brez mesečne naročnine in vezave,
- je enostaven za uporabo,
- deluje v najsodobnejšem mobilnem omrežju,
- zaračunavanje storitve **NET2GO** ni vezano na koledarske dneve, temveč je odvisno od trenutka aktivacije; za dostop vam zaračunamo takrat, ko internet dejansko uporabljate.

Paket **NET2GO** vsebuje:

- kartico SIM **NET2GO** z začetnim dobroimetjem v višini 4 EUR,
- certifikat **NET2GO** s kodama PIN in PUK,

Najnižje dobroimetje

NET2GO:

- Enables simple and extremely affordable wireless access to Telemach's mobile Internet
- Has no monthly subscription fees
- Requires no contractual obligations
- Is easy to use
- Works in the most modern mobile network
- **NET2GO** billing is not dependent on calendar days but depends on the moment of activation; you will be billed for access when you actually use the Internet.

NET2GO package includes:

- **NET2GO** SIM card with EUR 4 of preloaded credit
- **NET2GO** certificate with PIN and PUK codes
- Instructions for use and various printed materials with instructions and information.

Some **NET2GO** packages include a USB modem with a warranty certificate and USB Modem Instruction Manual.

NET2GO package includes a SIM card that enables **data packet transfer within the Telemach mobile network** and prepaid mobile communication services (calls, SMS messaging) billed in accordance with the **FREE2GO+** price list. You may upgrade the package by purchasing a USB modem which will automatically establish an internet connection upon first use.

Begin using the NET2GO prepaid mobile Internet

1. Insert the SIM card into the USB modem or another data device.
2. Before using the modem for the first time, check whether the user interface for accessing Telemach's mobile Internet has been installed on your computer. Upon switching on the USB modem or another data device, enter the PIN/PUK code. If you are using a USB modem, the computer will automatically establish an internet connection upon first use.
3. Connect to Telemach's mobile network.
4. Your SIM card was preloaded with EUR 4 of credit which ensures 96 hours of mobile internet access. When you first connect to the Internet, the SIM card is activated and the amount of EUR 1 is deducted from your account and a 24-hour period of unlimited use of mobile Internet is enabled.

The rest of preloaded EUR 3 can be used for 3 whenever you like. For every 24 hours of use, EUR 1 will be deducted. After that, you should top-up your account.

You may visit the moj.telemach.si portal to check the current balance on your account and the remaining time.

Topping-up your NET2GO account

You can top-up your account in two simple ways:

- Telemach prepaid voucher
- Polni zame service

Topping-up your NET2GO account with the Polni zame service

Polni zame is a Telemach service where a subscriber of Telemach can top up another Telemach prepaid user's prepaid account for the amount of EUR 5, 10 or 20.

NOTE:

How to top an account?

- **Using the USSD command**

For example, to top up in the amount of EUR 5:

Type *123*top-up value*telephone number that you want to top up# and press Call.

*123*5*070700700# and press Call.

- **Using an SMS text message.**

An example of topping up the account in the amount of EUR 5:

Send the following keywords to 7070: Polni, top-up value, the phone number you want to top up, and a message that the recipient will see after topping up.

For example: "Polni 5 070700700 Happy birthday!".

Where to buy Telemach prepaid vouchers

You may buy Telemach prepaid vouchers or electronic prepaid vouchers from Telemach stores or at 3,400 points of sale.

The validity of your SIM card and your NET2GO account balance.

Unused credit on your account may be used within 90 days since the last top-up to again access the mobile internet or any other services offered by the **FREE2GO+**.

After the 90-day period expires, the unused amount of the account is frozen, which means that the access to mobile Internet will not be possible while the balance is frozen. If the user tops up their **NET2GO** account within 180 days after the account was frozen, the frozen bonus will once again be available to the user. In the event that more than 270 days have passed since the account was last topped up, the **NET2GO** account and the SIM card will be permanently and irrevocably terminated and any amount that may have remained on the user's account will be permanently lost. The 90 or 270-day period begins when the user activates a 24-hour period of internet access or upon every time the **NET2GO** account is topped up.

In the event that the profile settings are not set up automatically or have been deleted by accident, you can enter them manually:

The prepaid period lasts 24 hours as of the moment of activation. Other services enabled by the **NET2GO** package are charged in accordance with the Price List of the **FREE2GO+** prepaid plan. You can find the Price list at www.telemach.si.

**The principle of fair use during data transfer in accordance with the Special Terms and Conditions of NET2GO Mobile Internet applies. After you transfer 3 GB of data in Slovenia within 24 hours after an individual service period has been activated, the maximum transfer speed is limited to 64 kbps.*

The trademarks and service marks mentioned in this document are legally protected marks of their owners.

The rate is activated once a data transfer is initiated and applies for 24 hours after activation.

When the user initiates another data connection, the rate is applied again and is active for another 24 hours.

Special Terms and Conditions for the Use of the services of the "NET2GO" Mobile Internet

With these Special Terms and Conditions for the Use of the services of the **NET2GO** Mobile Internet (hereinafter: "Special Terms"), Telemach d. o. o., Brnčičeva ulica 49A, 1231 Ljubljana - Črnuče, (hereinafter: "Telemach") amends the General Terms and Conditions for the Use of the Telemach Prepaid System (hereinafter: "SPU Terms") which are published online at www.telemach.si and apply in addition to these Special Terms and are as binding as these Terms. In the event of conflict between these Special Terms and the SPU Terms for mobile Internet services, these Special Terms apply. All terms used in these Special Terms have the meaning as defined in the SPU Terms, unless otherwise stated.

The user is obligated to use the **NET2GO** services in accordance with these Special Terms and with the respective instructions for use of the **NET2GO**

services which are enclosed with each **NET2GO** package and are published on the website of the company Telemach d.o.o.

NET2GO (mobile Internet) refers to technical and commercial services which are delivered through the electronic communications network of Telemach, with which Telemach enables the users of the **NET2GO** package, who do not enter into a subscription contract with Telemach and pay for the services in advance (hereinafter also: “prepaid users”), the use of services in relation to packet data transfer which are available as a part of the **FREE2GO+** prepaid plan. In accordance with the implementing regulation, Telemach set the volume limits during EU roaming that are listed among package properties in the Price list.

NET2GO services and other electronic communications services are billed in accordance with a valid price list included in the Instructions for Use and published at www.telemach.si. Telemach will publish any changes of the Price List, the SPU and the Special Terms, as well as other changes within the prescribed deadline and in the prescribed manner.

Migrating between packages

Telemach makes it possible for the users of the **NET2GO** package to conclude a Subscribers agreement with the same personal phone number that the user received for the **NET2GO** package. When the user switches from the **NET2GO** package to regular mobile Internet subscription, any possible remaining balance cannot be counted as credit towards the payment of monthly obligations under the regular mobile Internet subscription.

Switching from a regular subscription to Telemach's mobile Internet package or any other contractual subscription to the **NET2GO** package is not possible.

The MSISDN of another operator may not be used for the **NET2GO** package.

Lowest balance

The balance on your account may not be lower than EUR 1 for accessing the Internet. In the event of an active data session at the moment when the prepaid period expires or in the event of the commencement of a data session outside of the prepaid period, the next prepaid period is activated automatically for the user, provided that the account balance is sufficient.

Restrictions and the Rules Concerning Fair Use

If the user is in violation of the SPU Terms and/or these Special Terms and/or any valid regulations in a way that the violation represents immediate and serious threat to the public order, public security or public health or causes serious economic or operational issues to Telemach or third parties, Telemach may, without prior notice and setting the deadline for termination of violation immediately limit or cancel the provision of services. The

provision of this article does not limit Telemach in performing any other legally allowed acts or rights to protect the network, infrastructure or goodwill of Telemach or third parties.

Telemach shall not be held liable for any content published online or for any protection and privacy of data transferred over the Internet.

The user understands and agrees that the broadband internet access services by means of a mobile terminal may not achieve the highest declared bandwidth indicated for a particular connection type due to technology characteristics; natural or artificial barriers that stop or interfere with radio waves; large number of simultaneous users in a certain area; network design or purpose; or standards that were followed ; this service is also not intended for any environment, for which an absolutely uninterrupted internet connection, or a connection with a certain bandwidth, or the operation of other services or devices which depend on such a connection and are critical for the activities performed by the user, and for which disrupted services

or the failure of an individual data session may cause damage (critical environments). The user shall not use the services in critical environments. Telemach shall not be held liable for any form of damage which may be caused to the user due to the non-operation of the services at a particular micro-location or due to the non-operation of a connection with a particular bandwidth. The maximum bandwidth of the mobile broadband Internet has been determined in accordance with the specifications of the manufacturers of communications equipment which is used by Telemach to provide its services.

The principle of fair use of services applies to NET2GO.

Telemach designed the package with the purpose of providing a user experience which, for an average user, constitutes the unlimited use of services; it has done this by allocating such a high volume of services that the average user usually does not use it up in a specific period. In certain cases, especially when the use of this package begins to significantly deviate from average use or when Telemach uses traffic evaluation to assess that the user is not using the service in accordance with usual usage patterns of an average Telemach user (especially in the case of the use in P2P networks or with larger data transfers or transfers of a larger amount of files, and in the case of maintaining a consistent connection, regardless of speed), Telemach reserves the right, after sending a prior SMS notice or if the user does not immediately terminate its violations, to restrict the possibility of

the use of services in order to protect the quality of service, the integrity of the network, and the protection of the network from overloading; Telemach does this by implementing one of the following measures: **(i)** it restricts the transfer speed of data sessions, **(ii)** temporarily stops the use of services, **(iii)** begins charging excess use in accordance with the Price List, provided that such a measure is foreseen, or **(iv)** activates the next billing period. To avoid any doubt, normal use shall be seen as exceeded in any case if it exceeds 3 GB of data transfer any time within 24 hours after the activation of an individual period of validity.

Final provisions

Operating terms and conditions as well as the terms and conditions of the use of the **NET2GO** services are available for the users at any sales outlet authorized by Telemach to sell the **NET2GO** package, as well as on the Telemach website in order for the user to be able to familiarize himself with its contents before making the purchase.

By purchasing the **NET2GO** package, the user agrees that, before making the purchase, they familiarized themselves with the contents of these Special Terms for the use of the **NET2GO** mobile Internet services, the General Terms for the use of the Telemach prepaid system, the user guide, and the price list, and accept all obligations arising from these documents.

By purchasing the **NET2GO** package, the user confirms that, before making the purchase, they familiarized themselves with the operation of Telemach's mobile Internet and with the coverage of Telemach's signal. Users may familiarize themselves with this information at www.telemach.si.

These Special Terms for the use of the **NET2GO** mobile Internet services enter into force on 3rd April 2018 and shall remain in effect until they are modified or amended. Telemach shall publish any changes of these Special Terms at its website www.telemach.si at least 30 days before such changes are implemented.

The instructions for use of the **NET2GO** mobile Internet, the **NET2GO** price list, and the **NET2GO** operating terms and conditions as well as the terms and conditions for the use of services which are available on the website of the company Telemach d.o.o. are deemed to be the latest valid versions.
